INSTRUCTIONS

As set forth by the Alabama Department of Insurance, all insurers **DOING BUSINESS IN ALABAMA** are required to pay the following Annual Audit and Examination Fee.

- Fraternal Benefit Societies - \$400
- Surplus Lines Insurance Companies - \$1200
- All Other Insurance Companies - \$1200

The Annual Audit and Examination Fee is due March 1st of each year. All filings and payments must be remitted electronically through OPTins @ <http://www.optins.org>.

RE: Audit and Examination Fees
Rescinds: Bulletin No. 2012-08, dated October 1, 2012

1. Effective October 1, 2021, Bulletin No. 2012-08 dated October 1, 2012, is rescinded and replaced by this Bulletin.

2. In addition to the fees prescribed in Ala. Code §27-4-2, the following audit and examination fees are hereby required by this Department:

(a) **Filing of Annual Financial Statements:**

- (1) Mutual aid associations and fraternal benefit societies \$400
- (2) Health Maintenance Organizations \$500
- (3) All other insurers, including health care service plans \$1,200

(b) **Other filings:**

- (1) Quarterly financial statements \$100
- (2) Market Conduct Annual Statement (MCAS) \$200
- (3) Corporate Governance Annual Disclosure (CGAD) \$100
- (4) Own Risk and Solvency Assessment (ORSA) \$500
- (5) Insurance Data Security Certification \$250
- (6) Applications for original certificate of authority (other than captive insurers) \$2,000
- (7) Captive insurer applications for original certificate of authority \$200

(8) Foreign Insurer Examination Reports	\$300
(9) Applications for accepted reinsurer status	\$350
(10) Managing General Agent filings	\$250

3. The above fees are to be submitted contemporaneous with each filing. For detailed information relative to the submission of payment, please visit the Department's Website: www.aldoi.gov
