482-1-142-.01 Authority. This chapter is promulgated by the Commissioner of Insurance pursuant to Section 27-2-17, Code of Alabama 1975.

This chapter is intended to implement and interpret Sections 27-3-17, 27-27-4 through 14, 27-27-23, 27-27-24 and 27-29-3 Code of Alabama 1975, for the purpose of setting standards for the reporting of biographical data relating to company officers, directors, promoters and incorporators, or other persons similarly situated.

- (3) Motor club service companies.

NonDomestic Insurer. Biographical information in form and substance substantially in accordance with the current NAIC Biographical affidavit and authorization, (Attachment A) shall be furnished to the commissioner of insurance by all promoters, incorporators, directors, trustees and principal officers or proposed directors and principal officers, as the case may be, of an insurer being organized or of an insurer applying for admission. Financial and character reports of any such persons may be ordered by the commissioner and the cost or expense of such reports shall be paid by the incorporators as an organization expense or by the insurer applying for admission.

Such report shall be prepared by the company in form and substance substantially in accordance with the current NAIC Biographical affidavit, (Attachment A).
