PY 2025 Filing Guidance

EFFECTIVE: Immediate

Pursuant to the 2016 collaborative agreement between the Commissioner of insurance and the U. S. Department of Health & Human Services-Centers for Medicare & Medicaid Services, this Bulletin informs carriers of the filing deadlines for PY 2025 as they pertain to Alabama. Proposed Plan Year (PY) 2025 Qualified Health Plan (QHP) Data Submission and Certification Timelines were issued on November 16, 2023. The non-QHP form filings will follow the same timetable as QHP form filings.
